Bruce added on the Data Evaluation Task team that is evaluating the basis of the 1000 tickets looking at 9-10 states to compare the ticket scope and transmissions per ticket. Also Looked to change denominator to be in line with construction start, construction trend and GDP growth. Green analytics also



trying to look at total excavation since we can only look at excavation damage with a ticket, excavation damage without a ticket and excavation with a ticket; how do we know determine safe excavation without a ticket to get total excavation.



Adapting to the needs of a changing world, MISS DIG 811 welcomes the Collaborative Design Program. Building on our long-standing design ticket, this is a holistic approach to coordination. The program optimizes engagement of all current and future infrastructure owners, maximizing the investment and minimizing disruption to hard surfaces, existing infrastructure, and the public.

The Michigan Infrastructure Commission (MIC) reported a multi-billion-dollar requirement in annual updates for decades to come. The State of Michigan believes that the foundation of success in managing such a significant number of projects is cooperation between potentially conflicting projects during the design process. The MISS DIG 811 Collaborative Design Program addresses these challenges.

As a software, the program allows for communication, collaboration, and scheduling of work. It has the ability to unite involved parties by providing a platform on which they can communicate excavation and coordinate schedules to reduce the number of road openings and associated costs through shared excavation prior to a dig ticket being submitted and ground being broken. The program will:

- Provide opportunity to share excavation costs
- Extend road life
- Improve utility design
- Reduce risk for utility strikes and damages through better design
- Improve community awareness of projects



Through the MISS DIG 811 Collaborative Design Program, users can upload and share project plans, communicate between projects, isolate challenges and opportunities with other projects in the area,

and schedule and agree to shared excavation or schedule changes. The program is built on four basic principles:

- Job: A project with a defined location and description entered by a utility user
- Opportunity: Two or more jobs with similar start and end dates that do not overlap are within 330 feet of one another
- Challenge: Two or more jobs with start and end dates that overlap are within 330 feet of one another
- Exclusion Zones: An area which generates notifications designed to indicate specific constraints on work being permitted (e.g. a road moratorium or protected area)

Additionally, the program allows the designer to change visibility of a job based on the stage of the project, allowing users to manage whether it is for internal or public viewing. All jobs follow the same visibility hierarchy:

- Draft (for internal use)
- Private (shared with the territory owner)
- Public (shared with other organizations)

From the dashboard users can select any of their jobs; this screen gives a bird's eye view off all projects/jobs the company has on the system and provides the ability to view:

- Attachments
- Opportunities
- Challenges
- Collaborators
- Conversations

The MISS DIG 811 Collaborative Design Program allows users to navigate through a list of jobs their organization has entered. All jobs can be edited and modified to ensure that the project is defined correctly in terms of its geographic boundary, schedule, details, and visibility to other users. The conversations feature allows for multi-organizational discussion and the uploading of attachments to support the collaboration. As a tool, users can start a conversation with any other jobs that have been identified as being an "opportunity" or a "challenge" to the selected job.

The Collaborative Design Program will be available in the Fall of 2019. Following a brief training, existing design program users will receive their log-in credentials for the new platform. All new design users will be established on the Collaborative Design Platform. Facility owners will still have ten business days to respond to a design ticket, providing the size, type, and general location of their infrastructure.

MISS DIG 811 strives to bring the best programs and services to our members and users. We look forward to future features of the Collaborative Design Program including receipt of responses and plans from facility owners, as well as tools to make responding easier on the facility owners.

Marine Facilities Guide

To assist in facilitating the MDPB Best Practice, MISS DIG 811 has created a Marine member code (MRNE).

Code Features

- Waived Data Processing Fee (a \$369.00 savings)
- Waived transmission and maintenance costs associated with the code for the first year
- The facility owner can direct tickets that intersect with their under water facilities to a secondary location or parse ticket by the unique member code.
- Allows for additional Positive Response when the work site intersects the members underground and under water facilities
- Provides facility type: GAS, WTR, PL, BRNE, SWR, etc.
- Contains contact and historical information specific to the underwater facilities



- 1. Contact the MISS DIG 811 Member Services and tell them you want to take advantage of the Marine code.
- 2. The team will verify your information and send you the paperwork to collect the contact and delivery information necessary to establish the new code.
- 3. If you are using a contract locator, Member Services will confirm we have an Agent Letter on file that allows us to send the tickets to the third-party locator. If it is a new locator or if your existing documentation will not cover the new code, we will supply you with a new Agent Letter.
- 4. To complete, maps of the facilities will be needed and possibly removed from your existing database(s). Supply shape files for upload or take advantage of the three free hours of mapping services.
