

## **MISS DIG 811 Membership Options**

MISS DIG 811 offers a variety of membership options for Michigan stakeholders. Under Public Act 174 of 2013, facility owners are required to participate in the state notification center and receive and respond to dig and design tickets. In addition to membership for those required facility owners, MISS DIG 811 offers Associate Membership options. Below is a list of membership options, ranging in cost and access to the MISS DIG 811 system.

Associate Membership - Vendors



This membership is for stakeholders who want to support MISS DIG 811. This membership includes:

- Free Research Requests
- Company information listed on the MISS DIG
  811 website
- Access to the MISS DIG 811 online training
- Free attendance and an exhibitor's booth at the Annual Meeting
- 10% discount on all promotional items offered by MISS DIG 811

The annual fee for Vendor Associate Membership is \$150.00.

Associate Membership - Designers

In addition to the benefits of Vendor Associate Membership, designers will have the ability to place and manage design tickets (following online training).

The annual fee for Design Associate Membership is \$100.00 for the first user account and \$25.00 for each additional user account.

Associate Membership - Contract Locators

In addition to the benefits of Vendor Associate Membership, contract locators will receive locator codes on the MISS DIG 811 System necessary to manage and receive tickets on behalf of member facility owners. This membership also includes any associated Remote Member Access accounts. The annual fee for Contract Locator Associate Membership is \$500.00, plus \$87.00 for each facility owner member contracted to your account.

As previously stated, facility owners are required to become members under PA 174. In addition to all the benefits of Associate Membership, they receive member codes that are necessary to positively respond to dig and design tickets. Fees vary based on membership structure.
