ONE TICKET PER CALL

As of April 1, 2018 MISS DIG 811's Notification Center will only accept one ticket per phone call.

Placing tickets online is the best way to avoid long hold times.

There are two ways to place online tickets: e-Locate & Remote Ticket Entry (RTE).

- e-Locate- For single address requests. This does not require an account or training. You may access it from <u>WWW.MISSDIG811.ORG</u> or <u>ELOCATE.MISSDIG.ORG</u>.
- RTE- For excavators placing tickets on a daily or weekly basis. An account and training are required. For more information go to http://www.missdig.org/programs/remote-ticket-entry.html
